LEACH XPRESS PROJECT LANDOWNER UPDATE



DELIVERING APPALACHIA'S ENERGY POTENTIAL

Columbia Gas Transmission – a local energy company with more than 100 years of service to the region – is proposing a new pipeline project called Leach XPress to meet Ohio's and West Virginia's energy needs.

Energy exploration and development within the region has unlocked an abundance of natural gas – a clean, domestic energy resource that will fuel the nation and create local jobs and opportunity. For Ohio's and West Virginia's energy economies to grow to their full potential, new infrastructure is needed to safely and efficiently transport this resource to market.

The pipeline will travel from Marshall County, West Virginia through southeastern Ohio and include:

- > Installation of more than 150 miles of new 30- and 36-inch-diameter pipeline
- Construction of three new state-of-the-art compressor stations near Majorsville, West Virginia; Summerfield, Ohio; and Oak Hill, Ohio

WORKING WITH LANDOWNERS

As a landowner near a Columbia pipeline project, we consider you a partner in this effort. You can count on us to protect your privacy, respect your land and make safety and environmental responsibility our top priorities.

For several months, you and many of your neighbors have worked with representatives from Columbia who have surveyed the local area to find a pipeline route that will minimize land use, ensure safe construction and avoid sensitive environmental areas.

With land surveys nearing completion, we have entered a pipeline review and approval process overseen by the Federal Energy Regulatory Commission (FERC). The FERC process encourages the participation of landowners, local officials and communities as the agency conducts its comprehensive environmental review of the project. Columbia's project will also create approximately 1,500 direct construction jobs in Ohio and West Virginia at the peak of construction and create or support more than 4,800 jobs of all types through 2017. In addition, the project is expected to generate upwards of \$35 million in new tax revenue for vital local services like public education.
