Re: South Bow GP (Canada) Ltd., as general partner on behalf of South Bow (Canada) Limited Partnership (South Bow) Filing of Liquids Pipeline CER Tariff No. 69 (Toll Schedule)

Pursuant to Section 229(1)(a) of the Canadian Energy Regulator Act, South Bow files the enclosed international joint rate tariff, CER Tariff No. 69, to be effective on August 1, 2024.

South Bow, and in agreement with, TransCanada Keystone Pipeline, LP, by its general partner, TransCanada Keystone Pipeline GP, LLC is filing to update the Abandonment Surcharge as outlined in Note 3) of CER Tariff No. 69. This update is being made to reflect a decrease in the Abandonment Surcharge which was filed with the Canada Energy Regulator as CER Tariff No. 68 on July 4, 2024. The adjustment to the Abandonment Surcharge was made pursuant to the CER's 2021 Five-Year Review of Abandonment Cost Estimates and Set-Aside and Collection Mechanisms. This tariff is filed concurrently with the Federal Energy Regulatory Commission in the United States as FERC No. 7.35.0.

This filing also provides administrative updates to reflect the corporate name change from TransCanada Keystone Pipeline GP Ltd. to South Bow (Canada) Ltd. in Canada.³

South Bow provides notice of this filing to Liquids Pipeline shippers and interested parties.
