Report on Climate-related Lobbying





Introduction

As a leading North American energy infrastructure provider, TC Energy has an important role to play in developing clean energy solutions that promote security and prosperity for energy users worldwide.

We firmly believe that the energy industry must play a proactive role to effectuate change. TC Energy engages with governments and other stakeholders – such as trade and industry associations and coalitions (collectively, "trade associations") – to support balanced policies, legislation and regulations that will play an important role in advancing a net-zero emissions economy, while addressing global energy security, affordability and sustainability.

We have developed, in connection with these efforts, the following climate lobbying policy statement to help guide our engagements:

CLIMATE LOBBYING POLICY STATEMENT

TC Energy is uniquely positioned to help advance a clean energy transition that promotes security and prosperity for energy users worldwide. We have established climate-related goals to reduce the greenhouse gas (GHG) emissions intensity from our operations 30 per cent by 2030 and position us to achieve zero emissions from our operations, on a net basis, by 2050.

We will continue to be a voice for thoughtful and balanced solutions that drive global growth and emissions reductions through infrastructure development and a leveraging of North America's abundant energy resources.

We will advocate for policies that are consistent with our climate-related goals, support deployment of clean energy systems, a robust energy trade, a strategic diversification of our energy mix, and an advancement of the aspirational pursuit of limiting a global temperature increase to 1.5°C.

While we support the aspirational goal to limit global warming to 1.5°C, we do not unequivocally support any legislation or regulations that are aimed at limiting global warming. A specific piece of legislation or regulation, while well intentioned, may not be effective or optimally designed to achieve the intended objectives and can sometimes result in unintended consequences. This report provides information about our climaterelated lobbying and advocacy activities and assesses alignment of the climate-related policy engagement of our primary trade associations. We outline the framework used to determine alignment, partial alignment and misalignment in the assessment, and the steps taken to address position differences.

Climate-related lobbying and trade association activities

Climate-related lobbying

We believe that greater collaboration between governments and businesses is essential to building the best framework to tackle climate-related challenges and that thoughtful regulations can be an engine for responsible growth. To that end, we are engaging with governments across Canada, the U.S. and Mexico on this topic. Our climate lobbying efforts focus on contributing to the development of responsible public policies and regulatory processes. Some examples of our continued engagement efforts include:



It takes multiple years to receive regulatory approval to sanction projects in Canada. We are engaging with various levels of government on permitting reform to accelerate the regulatory process. Permitting reform and policy support are critical to our ability to achieve our climate goals.

Earlier this year we continued our ongoing engagement with the Government of Canada as they developed and refined their proposed regulatory framework for reducing oil and gas methane emissions by at least 75 per cent by 2030. We are leveraging our 70+ years of experience operating natural gas pipelines and our experiences with methane leak detection, monitoring and reduction technologies to provide practical and databased recommendations to help inform the most effective solutions for achieving methane emissions reduction targets.



We are engaging on suggested reforms to permitting processes that will enable more efficient development of infrastructure needed to meet energy and sustainability goals.

We are expressing support for tax policies that incentivize early investment in clean energy systems.



TC Energía engages with legislators on a wide array of topics, but direct lobbying on legislative matters is conducted through industry associations.

 Harmonizing North American regulatory policies and enhancing cross-border coordination is critical to successfully decarbonizing our economies while also upholding our obligation to provide abundant, affordable and reliable energy to our consumers. We are proposing improved coordination on climate and energy policy across North America's national jurisdictions to better leverage our resource base and energy connectivity.

By addressing regulatory hurdles that hinder trade and investment, reformed policies can foster a more conducive environment for collaboration between different entities and accelerate common decarbonization goals.


Participation in trade associations

In addition to our direct climate lobbying activities, TC Energy shares our perspective on emerging climate-related policy issues with third parties, such as trade associations and policy organizations across our lines of business.

TC Energy's trade association memberships are an important part of our collaboration within the policymaking process. Our participation provides a forum to exchange knowledge and expertise on many topics aligned with the company's values, strategy, and operations and helps foster industry dialogue on important issues like climate change. We generally consider several factors when joining trade associations and reviewing our existing memberships; however, our primary purpose for involvement in trade associations is to support business efforts and participate in technical and industry discussions with policymakers and regulators.

While trade associations and policy organizations may use membership fees for lobbying purposes, TC Energy does not direct how membership fees are used, and payment of membership fees does not necessarily reflect an endorsement of every position taken by such organizations. Some trade associations engage in lobbying and advocacy on matters that they consider to be important to their members, or to the issues or sector that they represent.

Positions taken by a trade association on any topic reflect the views of a majority of its members. But members often have conflicting views on specific aspects of proposed policy and/or the advocacy strategies designed to advance it. As a result, our positions on issues, and those of specific trade associations, do not align all the time. Collaborating only with those who share our position on every topic would limit constructive opportunities for achieving our climate goals. Our priority is to influence outcomes rather than walk away from the debate, as continuous involvement provides the best opportunity to foster more complete alignment with our own values and principles.




Governance and oversight

TC Energy's Board of Directors provides oversight and direction in the strategic planning process to foster the long-term success and sustainability of our company. The Board reviews and approves our strategic plan and monitors its implementation considering specific and emerging issues, including progress towards our emission reduction goals.

The Governance Committee of the Board oversees lobbying, political contributions, and corporate memberships. The Committee receives a report annually that provides information on our lobbying activities, a complete list of our political contributions and a detailed list of our corporate memberships, including industry associations and policy organizations.

TC Energy maintains registrations for lobbyists where required by law. Our lobbying activities are registered in various jurisdictions in Canada and the U.S., many of which provide public disclosure with details of registrations. Links to each of the lobbyist registrations, where available, can be found in Appendix A of our information sheet: <u>Oversight and policies on lobbying</u>, political contributions and corporate membership.

We also maintain a number of policies that govern lobbying practices including our internal <u>Political</u> <u>Contributions and Activities Policy</u> and <u>Code of Business</u> <u>Ethics Policy</u>.



Criteria and assessment of alignment to climate lobbying policy statement

All TC Energy lobbying and advocacy activities are undertaken in accordance with the requirements of the respective jurisdiction and our Political Contributions and Activities Policy.

POLITICAL ENGAGEMENT PROCESSES

TC Energy is committed to actively managing public policy issues that have an impact on our company in a manner that aligns with our climate lobbying policy statement and climate-related goals. Our <u>lobbying information sheet</u> outlines the policies and considerations that go into the approval of political activities and corporate memberships, including alignment with TC Energy's strategic focus areas.

Trade associations and memberships

In early 2023, we conducted a review of how key trade associations' climate-related activities and positions align with our climate lobbying policy statement. We developed and distributed a standardized survey to 10 organizations reflecting associations' within the memberships portfolio in which annual dues paid were \$50,000² or greater and the organization is likely to take a position on climate change and/or energy advocacy, as we believe these are the most significant and most likely to be of interest to stakeholders.

The following high-level climate-related positions serve as a framework for our climate-related policy advocacy and the basis for this trade association and membership climate review:



TC Energy publicly commits to help advance a clean energy transition that promotes security and prosperity for energy users worldwide with climate-related goals.



TC Energy supports goals of limiting average global warming to well below 2°C above preindustrial levels and the aspirational pursuit of limiting the temperature increase to 1.5°C.



TC Energy supports deployment of clean energy systems, a robust energy trade, and strategic diversification of our energy mix.

Assessment of alignment

We determined the extent of overall alignment for each association based on survey responses received as compared to our high-level climate-related policy positions.

In general, associations that were deemed to be **aligned** were those that we found to have:

- Stated positions, advocacy or activities limiting global warming to well below 2°C above pre-industrial levels and pursuing efforts to limit temperature increase to 1.5°C;
- Stated positions, advocacy, or activities for access to sufficient, affordable clean energy;
- Stated positions, advocacy, or activities addressing issues related to climate, emissions reduction, and/or energy (including less carbon-intensive, low-carbon and renewable energy); and
- No significant misalignments in other areas.

Associations deemed **not aligned** were found to have stated opposition to limiting average global warming to well below 2°C above pre-industrial levels and pursuing efforts to limit the temperature increase to 1.5°C, no advocacy positions or activities promoting access to sufficient, affordable clean energy and no climate, emissions reduction, and/or energy advocacy positions or activities.

An association was assessed as **partially aligned** if we found that it did not meet the criteria for either aligned or not aligned.

In some cases, further interpretation or additional review of publicly available information was needed.

Actioning misalignment

In instances of topic misalignment, we consider:

- Ongoing monitoring and focused reviews of key trade associations' views on key positions;
- Value of the trade association membership on issues not directly linked to climate policy;
- Continued discussion with trade association staff and its members;
- Active engagement designed to drive consensus positions;
- Public dissent from association positions, including not providing formal company participation or endorsement; or
- Membership resignation in instances of material misalignment on high-priority policy issues.

We understand the climate-related positions of our trade associations will continue to evolve. Accordingly, TC Energy intends to monitor the positions and actions of our trade associations and memberships to assess whether misalignment warrants ending our participation in a particular association.

Trade association findings

We found four associations to be aligned, and six partially aligned, with our high-level climaterelated policy positions. No trade associations or memberships were identified as misaligned.

American Gas Association (AGA)³

Overview: AGA represents companies delivering natural gas safely, reliably and in an environmentally responsible way to help improve the quality of life for their customers every day. AGA's mission is to provide clear value to its membership and serve as the indispensable, leading voice and facilitator on its behalf in promoting the safe, reliable and efficient delivery of natural gas to homes and businesses across the nation. AGA is committed to reducing greenhouse gas emissions through smart innovation, new and modernized infrastructure, and advanced technologies that maintain reliable, resilient and affordable energy service choices for consumers.

We took this approach for reasons of rigor, consistency and objectivity; however, we recognize this approach has its limitations. This review does not reflect the full spectrum of activities historically or currently undertaken by these organizations on climate change issues. Further, this report does not reflect activities of the trade associations outside of climate change, such as safety standards, economic development, and tax policy.

Not every climate-related issue is necessarily covered by the high-level positions we have set out; and some areas of potential alignment or misalignment may arise at a level of detail or nuance not readily captured by this approach.



Next steps

At TC Energy, we are dedicated to actively managing public policy issues that have an impact on our company and our ability to execute on our GHG emissions reduction commitments and targets. In fact, we have a responsibility to our shareholders, employees and customers to represent their interests in public policy and advocacy discussions that are related to our industry and impact our business.

As we look toward our climate-related goals in support of limiting average global warming to well below 2°C above pre-industrial levels and pursuing efforts to limit the temperature increase to 1.5°C, the energy sector will require supportive legislative and regulatory policies to enable the deployment of emissions reduction initiatives, emerging low-carbon fuels and infrastructure, and other decarbonization solutions. We will continue to be a voice for thoughtful and balanced solutions that drive global growth and emissions reduction through infrastructure development and a leveraging of North America's abundant energy resources.

We are committed to transparent disclosures about our lobbying activities. We plan to provide periodic updates internally, to our Board of Directors, and to stakeholders as appropriate. We will provide a progress update on our trade association alignment in our annual sustainability report.
